

Texcom Announces Results for First Half of 2019

OKLAHOMA CITY, OK – July 18, 2019 - Texcom, Inc. (the "Company" or "Texcom"), an environmental services company serving the oil and gas industry, today announced financial results for the first half of 2019. Results for the first half of 2019 were as follows:

- Revenues totaled \$964,000.
- Operating profit was \$57,000.
- Interest expense was \$499,000.
- EBITDA was \$408,000.
- Net loss was \$392,000.
- Loss per share was 3.40 cents
- Total liabilities were \$8.9 million at June 30, 2019.
- Total equity was negative \$7.1 million at June 30, 2019.

During the third quarter of 2019, we expect commercial operations to begin at the Class 1 Industrial Waste Disposal Facility in Montgomery County, Texas owned by Texcom Gulf Disposal, LLC ("TGD"). TGD recently changed its name to Union Processing Systems, LLC ("UPS"). Texcom, Inc. owns 20% of UPS. While UPS has a substantial amount of debt (approximately \$19 million), robust operations might retire this debt and provide future cash flow to the Company.
