

Texcom Announces Results for 2020

OKLAHOMA CITY, OK – February 4, 2021 - Texcom, Inc. (the "Company" or "Texcom"), an environmental services company serving the oil and gas industry, today announced financial results for 2020. Results for 2020 were as follows:

- Revenues totaled \$1,031,000.
- Operating loss was \$515,000.
- Interest expense was \$676,000.
- EBITDA was \$85,000.
- Net loss was \$1,191,000.
- Loss per share was 10.34 cents
- Total liabilities were \$9,341,000 on December 31, 2020.
- Total equity was negative \$8,595,000 million on December 31, 2020.

The principal and accrued interest on our bank loan became due on January 31, 2021. At this time, we have not entered into a modification agreement or an extension with the bank.

Commercial operations at the Class 1 Industrial Waste Disposal Facility in Montgomery County, Texas owned by Union Processing Systems, LLC ("UPS") continue to ramp up. While UPS has substantial debt to repay, the Company is optimistic that it will receive cash flow from its 20% ownership of UPS in the coming years.
